# COMMUNITY PROFILE



Ottawa County is located on the northern boundary of the State of Ohio on the shores of and into Lake Erie. According to the Ohio Genealogical Society, the county encompasses 254.7 square miles of land. However, its legal boundary includes an additional 330 acres of the water of Lake Erie. Of the 88 counties in Ohio, there are only two counties that are smaller in land mass. One of those smaller counties is nearby Erie County.

Established on March 6, 1840, it was formed from portions of Erie, Lucas, and Sandusky Counties. The western area of the county was the last to be settled as it was part of the Great Black Swamp. The eastern area was part of the Connecticut Western Reserve and was the first area to be settled and developed. The county has twelve townships, one of which is Put-in-Bay township and includes several islands in Lake Erie.

With its proximity to Lake Erie, the county is a popular destination for recreation opportunities related to access to Lake Erie. The U.S. Census Bureau reports that as of July 1, 2024, the population of Ottawa County is 39,692. That number reflects a decrease of 111 from the 2023 figures. Overall, the permanent resident population has been decreasing since 2010 and is projected to continue to decrease in the coming years (Ohio Department of Development).



Access to Ottawa County includes many state highways including the Ohio Turnpike and State Route 2, major east/west corridors passing through the county. There are numerous other state highways crossing the county providing access to residents and visitors.

There is one city in the county, Port Clinton. This community serves as the county seat. There are seven villages including Clay Center, Elmore, Genoa, Marblehead, Oak Harbor, Put-in-Bay, and Rocky Ridge. Additional unincorporated communities are sprinkled throughout the county.

With its proximity to Lake Erie, Ottawa County is home to a significant number of parks and nature preserves that draw thousands of visitors annually. Ottawa National Wildlife Refuge, Magee Marsh, Perry's Victory and International Peace Memorial, Catawba Island State Park, Oak Point State Park, North Bass Island State Park, Middle Bass Island State Park, and East Harbor State Park are found in the county. There are also additional private preserves located in the county.

Seasonal visitation to the county creates a number of challenges to both the permanent residents and visitors. Traffic flow is a problem during the peak recreation season. Recent studies conducted by the Park District of Ottawa County seek enhanced access to off-road trails that will connect people and communities throughout the county. These include the Catawba Islander Trail and Greenway Master Plan and the Marblehead Peninsula Trail Feasibility Study.

With its proximity to Lake Erie and the abundance of recreation opportunities, Ottawa County is expected to continue to attract visitors in the future. Ottawa County is expected to continue to have an abundance of recreation opportunities related to Lake Erie. While the permanent resident population is projected to decline (U.S. Census Bureau), the seasonal population will likely grow.





# ORGANIZATIONAL PARKDIS PROFILE





In 1992, Ottawa County resident, Attorney Mark E. Mulligan, requested that the Ottawa County Commissioners consider adopting a resolution for the formation of a park district that would include all territory within Ottawa County. After discussion, the commissioners passed a resolution requesting Ottawa County Probate Court conduct a public hearing regarding the creation of a park district. The resolution stated, "... the creation of a county-wide park district would be the most effective and efficient means to establish the orderly development, operation, acquisition, and maintenance of park and recreation facilities and activities for the citizens." It further stated that the Board of County Commissioners supported the creation of a park district as outlined in Section 1545.01 of the Ohio Revised Code. The resolution was delivered to Ottawa County Probate Court on July 17, 1992.

After receiving the resolution from the county commissioners, Probate Judge David Zeitzheim scheduled a hearing in the matter for August 24, 1992, at 9 a.m. Those in attendance at the hearing, including Attorney Mark E. Mulligan, supported the creation of a park district. After consideration of the evidence presented at the hearing, on September 1, 1992, Judge Zeitzheim ordered the creation of the Park District of Ottawa County to include all areas of Ottawa County.

Chapter 1545 of the Ohio Revised Code provides for the operation of park districts. Section 1545.11 states, in part, "The board of park commissioners may acquire lands either within or without the park district for conversion into forest reserves and for the conservation of the natural resources of the state, including streams, lakes, submerged lands, and swamplands, and to those ends may create parks, parkways, forest reservations, and other reservations and afforest, develop, improve, protect, and promote the use of the same in such manner as the board deems conducive to the general welfare."

After its creation in 1992, the park district initially focused on working on grant opportunities to assist with the development of the North Coast Inland Trail within Ottawa County. With limited funding opportunities, the park district had no opportunities to grow. In 1999, Sandusky County Park District purchased a section of the North Coast Inland Trail corridor in Ottawa County. In the ensuing years, this

portion of the trail was improved. In 2018, Sandusky County Park District transferred its ownership of the trail to Ottawa County Commissioners.

Also in 2018, Ottawa County Commissioners formed a steering committee to create an Ottawa County Active Transportation Plan. The committee began its work on April 25, 2018, with representatives from many Ottawa County organizations, subdivisions, and residents. The park district was an active participant in the planning process. Funded by the Ohio Department of Transportation, the Active Transportation Plan Committee was to examine the needs of the community including alternatives to vehicular traffic as well as the promotion of healthy living conditions within the county.

The Steering Committee met monthly starting in April of 2018 through September. In addition, public meetings were held on June 6, 2018, at the Ottawa County Fairgrounds and on August 29, 2018, at the Shores & Islands Welcome Center to gather input on the Active Transportation Plan.

During the development of the Active Transportation Plan, it became clear that residents and visitors supported the creation of safe bicycle facilities in Ottawa County. Due to heavy traffic conditions, especially on weekends, the ability for both year-round and seasonal residents to use safe bicycle routes would help reduce traffic levels on both local and state roads. It would also provide an economic benefit to local businesses that would have access along the bicycle routes. Most supporters of the Active Transportation Plan noted that safe, offroad trails would be the preferred design. The final plan was adopted on November 1, 2018, and included mapping of various trail opportunities throughout the county as well as discussion of potential funding opportunities and maintenance of new trail corridors.



Strategy 1 of the Active Transportation Plan called for an active Ottawa County Park District. Since its formation in 1992, the park district had not developed a funding mechanism and had become inactive. On February 13th, 2020, Ottawa County Probate Court appointed two additional commissioners to the park district board at the request of the park district. With the new members, the board set about organizing the park district, developing its administrative policies, and seeking funding for the full operation of the district.

In May 2020, the park district contacted The Trust for Public Land for guidance with developing a funding model for the park district. The Trust agreed to provide

assistance in the form of a feasibility study that would examine potential sources of funding. The study included a phone poll conducted by John Wilson Research of Alexandria, Virginia. With limited funding options provided in the Ohio Revised Code, this poll tested public support for a ballot issue that would enact a real estate tax in the amount of .6 mill to benefit the park district. The ballot language proposed was as follows: "An additional tax for the benefit of The Park District of Ottawa County for the purpose of preserving land to protect drinking water sources and the water quality of rivers, lakes and streams, protecting natural areas and wildlife habitat, connecting existing parks and preserves with recreational trails, acquiring and improving new parks, and assisting in maintaining, improving, and operating existing parks, at a rate not exceeding six-tenths (0.6) of one mill; for each one hundred dollars of valuation, for a period of eight years commencing in 2021."

Those surveyed were given the opportunity to react to the ways in which the funding would be used. The five uses generating the most positive responses included the following (ranked from highest to lowest).

Protect the water quality of Lake Erie (79%)

Preserve land to protect drinking water sources (78%)

Protect the water quality of rivers, lakes, and streams (76%)

Provide nature education for children (70%)

Develop and maintain recreational trails for walking and biking (69%)

The survey responses provide a road map for activities of the park district. It concluded there was strong support for a levy to support the park district going forward. With the information provided by the survey, the park district board of commissioners placed a ten-year levy on the November 2020 ballot using the ballot language as follows:

An additional tax for the benefit of the Park District of Ottawa County for the purpose of operating, promoting, conserving, acquiring, developing, improving and protecting lands and water areas as parks, trails, both bike and walking, and forest reservations at a rate not exceeding 0.6 mill for each one dollar of valuation, which amounts to \$.06 for each one hundred dollars of valuation, for a period of ten years commencing in 2020, first due in calendar year 2021.

The levy was passed with just over sixty percent of voters approving. The ballot language will continue to guide the park district in the expenditure of its funds.



Following passage of the levy to support the park district, the board began working on a plan for startup of operations and working on behalf of the residents of Ottawa County. The first paid staff member of the park district was added in 2022 when Jannah Wilson was hired as the Executive Director of the park district. Jannah came to the park district with a degree from Central Michigan University with a Major in Outdoor Recreation and a Minor in Natural Resources. She has

worked at several park locations in Michigan and moved to Ohio when she became employed as a full-time naturalist with Lorain County Metro Parks. She served as Outdoor Experiences Manager from 2019-2021.

In addition to the director, a part-time administrative assistant has been added along with a seasonal/intermittent operations assistant. The park district currently operates from rented office space in Port Clinton.

In 2023, the park district approved the Catawba Islander Trail and Greenway Master Plan. The plan envisions a trail that will run from the north to the south end of Catawba Island. The total plan envisions five phases, each taking three to five years to complete. A more detailed study was conducted of the Phase One area with more detailed route options and preliminary cost estimates.

Also in 2023, the Black Swamp Conservancy donated a twelve-acre parcel of land on West Harbor for future park development in Catawba island Township. A Marblehead Peninsula Trail Feasibility Study was begun in 2023 with completion scheduled in 2025. The Park District also approved monetary support for the Port Clinton Recreational Amenities Plan.

In 2024, the park district acquired a key parcel on Catawba Island that will become a trailhead for the Catawba Islander Trail. The seven-acre parcel was acquired with a grant from the Clean Ohio Fund. Master planning for the development of this park and the land donated by the Black Swamp Conservancy is currently underway.

Also in 2024, the park district assisted with funding an extension of the North Coast Inland Trail through Veterans Park in Genoa. An Ohio Department of Transportation TAP Grant was secured to extend the trail from Veterans Park to Millbury. Funds were also provided for planning and engineering of further improvements to the North Coast Inland Trail to convert a trail segment from on-road to off-road. The Marblehead Peninsula Trail Feasibility Study was completed and approved by the board in April 2025.

Since the hiring of the director, the park district has worked to increase its presence in the county through programs and events. Park district marketing initiatives have included e-newsletters, a Facebook page, press releases, website updates, and the development of informational brochures and logo-printed items for distribution at events throughout the county.

Friends of Ottawa County Parks is a 501 (c)3 charitable organization that exists to assist the park district with its mission. Friends supports the park district through volunteerism and financial resources. The group recently conducted a strategic planning process and meets regularly.

As provided in the ballot language, the park district established a Parks and Trails Improvement Grant program to assist local political subdivisions with park and trail improvements throughout Ottawa County. Through 2024, the program has awarded grants totaling more than \$700,000.



# STAKEHOLDER MEETING



The park district invited local stakeholders to attend a meeting on August 22, 2024, to discuss the strategic operation of the park district and future planning. Held at the Oak Harbor Public Library, the sixteen attendees included representatives from local governments, federal agencies, non-profits, and the park district. A copy of the meeting notes and attendance are located in Appendix A.

A presentation outlining a history of the park district was given to attendees. Information was also shared regarding the statutory requirements for the district. A description of activities of the district since the passage of the levy in 2020 was included. First collection of revenue from the levy began in 2021.

A public opinion survey conducted by the Trust for Public Land before the levy passage created a basis for the operation of the park district going forward. Environmental and water quality preservation were most important with recreation and public programming also being ranked as important.

The park district began its work in the county with the survey results in mind as well as the statutory requirements for park district operations. These activities were presented to attendees and are outlined in the Organizational Profile in this document. After the presentation, attendees were asked to provide input regarding the performance of the park district and what, if anything, the park district should change.

The significance of the Parks and Trails Improvement Grant program to local communities was emphasized by local government representatives in attendance. The availability of funds to help improve local parks has been a game-changer for communities in the county. The continuation of this program is essential to future improvements of local parks.



An increase in public programming, both recreational and educational, was also identified as important. Additional staffing was recommended to improve this aspect of the operation of the park district. Some in attendance volunteered to assist with programming until park staffing is available for this task.

The importance of the expansion of trail corridors within the county was stressed by several in attendance. The presentation included information regarding trail projects that are ongoing with the county. This will continue to be a high priority going forward.

Comments about the progress of the park district since funding became available were positive. It is important to continue to make progress in improving parks, adding recreation opportunities, and adding educational programs moving forward. A copy of the presentation made at the meeting is available in Appendix B.




## PUBLIC INPUT SURVEY



As a part of the strategic plan process, an online survey was developed to communicate the accomplishments of the park district and to gather public input on goals for the park district through the current levy period and beyond. A copy of the survey results is included in this report and is in Appendix C. The park district publicized the survey through email blasts, online posts, and in local newspapers. The survey was available from November 8-29, 2024. A total of 104 responses were received.

Thirteen potential goals were listed. Respondents were asked to select their top three goals. Six of the stated goals were most often selected. The top six goals, listed in order, were as follows:

- 1. Look for opportunities to preserve natural resources in Ottawa County. (44.23%)
- 2. Continue to work on the development of trail corridors in the Marblehead Peninsula and Catawba Island areas. (41.35%)
- 3. Plan for the financial stability of the park district beyond the current levy period. (39.42%)
- 4. Continue to award grants to local parks through the Parks and Trails Improvement Grant Program. (32.69%)
- 5. Development of new park sites, Catawba Islander Woods and Trailhead, and West Harbor Preserve. (30.77%)
- 6. Work toward the completion of improvements to the North Coast Inland Trail utilizing park district and grant funding. (25%)



While the top three goals were closely rated, natural resource preservation was clearly the most popular. Trails were also popular, appearing in three of the top six goals. Other proposed goals were selected less frequently but remain as important considerations for the park district. For example, the goal of finding a home for the park district was not selected very often but remains important to the operation of the park district. Similarly, the goal of adding staff where needed to maintain parks and conduct programs was the least popular, however it can be important to secure support for the park district in the future through well-maintained trails and programs that are accessed by residents. In addition to selecting the top three goals, respondents were given two open-ended questions seeking additional information.

#### What amenities would you like to see as new parks are created in Ottawa County?

Probably the most reoccurring theme in the responses to this question were bike trails, nature trails, community connectivity, and walking paths (including ADA accessible trails). These responses are in line with the park district's emphasis since it was created. Numerous responses mention access to safe bicycle routes in the Marblehead and Catawba areas.

Other responses included typical amenities found in parks such as restrooms, shelters, dog parks, parking, programming, playgrounds, water fountains, trash cans, etc. One respondent mentioned expanding park access in the western area of the county.

The complete list of responses is in Appendix C. Of the 104 who responded to the survey, 73 entered a response to this question.

#### How are we doing?

The danger that comes with inviting input on your organization includes having several negative comments posted relative to individual pet peeves. It is clear from the responses received related to this question that most of the respondents feel that the park district is doing a great job.

The majority of the responses demonstrate that the community is impressed with the progress made this far and recognize that funding has only recently become available to support the operation of the district. There were mentions of doing a great job with limited resources and encouragement to continue seeking grant funding as well.

Trails were mentioned several times by those responding. Expanding parks into Western Ottawa County was mentioned again under this question, by the same respondent to the question above as demonstrated by the time and date stamp. Seventy-one people provided answers to this question.

#### What are we missing?

This question had the least responses, with sixty-three people taking the time to record their answers. The list varies. There were some common themes in the responses. The need for safe bicycle trails was raised on several occasions. The need for better communication about the district and its programs came out in several answers.

Interestingly, the need to expand the park district through land acquisition was mentioned several times, showing concern over the loss of land to development. One respondent felt that a more visible location of an office complex was important along with staff supporting the operation of the park district, its improvements, and programs. A full list of responses to this question is found in Appendix C.

The responses to the survey show strong support for the park district, its goals, and its achievements since the passage of the levy. There were several responses from the Catawba Island area that demonstrate some concern about the park district's efforts in that area. There were also a few responses about property taxes that demonstrate the need to be aware of some anti-tax sentiment in the community.



## BENCHMARKING



Eight park districts were selected for the benchmarking survey. These districts are spread throughout the state and were all asked to respond to a list of twenty-six questions regarding funding and operation. A chart listing the responses from each district is in Appendix D.

Levies for all of the selected districts have been voted on in the last ten years. The largest levy in place is in Sandusky County at one mill. The lowest levy in place is in Ross County at two-tenths of a mill. The funding generated by a real estate levy varies greatly based on the economic development of each county. Half of those surveyed are operating with a five-tenths of a mill levy. Funding generated is between \$620,000 and \$750,000. Most of the levies supporting the park districts surveyed are for a period of ten years. None included in the benchmarking had more than one levy in place.

The amount of land controlled by the district and the number of open parks varied based on the age of the levy. The smallest number of open parks was in Richland County, which passed its first levy in 2023. The smallest amount of land was in Auglaize County with just forty acres. This district also passed its first levy in 2023.

As expected, staffing levels varied with the number of parks and the length of time the district has had a levy in place. In Sandusky County, the park district has been supported by a levy for many years. The current one mill levy was passed in 2016 and generates \$1,000,000 annually. The presence of a swimming area and campgrounds leads to higher staffing levels.

All the park districts had a staff member dedicated to programming. One had four and another added five to six seasonal employees for programming. Most park districts throughout the state see public programming as an important way to maintain support for the district and its operations.

All park districts reported trails as an important amenity. While some did not report the total length of nature trails, all have them. The popularity of paved trails is also evident with all districts reporting varying length of paved trails in place.

Most of the established districts have purchased vehicles and equipment used in the operation and maintenance of the parks. Most districts also use employees and volunteers for mowing activities. Two contract most of the mowing with a third considering using contractors. This is a growing trend in parks as it is becoming more difficult to hire and retain maintenance employees. It reduces operational costs when maintenance staff is reduced to those who have responsibility for fleet and building management. It also lessens the need for capital equipment. Licking Park District has been successful with a mowing contract program.

The strength of park districts throughout Ohio has been the ability to operate under Chapter 1545 of the Ohio Revised Code to meet community needs. Each district has a slightly different approach to its mission. The focus of each of the park districts surveyed centered around conservation, passive recreation, and nature education. Ross County Park District divides its budget equally between trail development and programming. Auglaize County Park District is primarily focused on land acquisition and opening new parks since this is its first year of funded operations. The information provided from other park districts supports the primary focus of The Park District of Ottawa County.



# FISCAL REVIEW



As noted in the Community Profile, the park district operates under Chapter 1545 of the Ohio Revised Code. The manner in which park districts are able to raise funds is specified in Sections 1545.20 and 1545.21.

#### **INSIDE MILLAGE**

Section 1545.20 permits the levy of one-half mill of taxes on properties located within the park district as a portion of inside millage for the county. Inside millage is authorized by Section 133.17 and is available for any authorized political subdivision. However, inside millage is limited to ten mills and in Ottawa County, all of the ten mills had been authorized for other political subdivisions before the park district was created.

### TAX LEVY FOR USE OF PARK DISTRICT - SUBMISSION TO ELECTORS, BONDS

Section 1545.21 outlines the process for a park district to submit a tax levy to the voters for approval. These levies can be submitted to the voters at any general election. The process to submit an issue to the voters is spelled out in this section of the Ohio Revised Code and is the process that was utilized to submit the first levy for approval. A park district cannot ask for more than two mills in any single request (unless the park district operates a zoo). Once a levy is passed, this section also describes the manner in which tax anticipation bonds can be issued for improvements. The length of the levy is determined by the ballot question authorized by the board of park commissioners. The current levy for the Park District of Ottawa County was approved for ten years.

#### **EXPIRATION OF THE LEVY**

Section 1545.21 also provides the process for renewing or replacing a levy upon expiration. If the levy is to be renewed, it may first be placed on the ballot in November of the year that the levy expires. Should the levy fail, the commissioners can submit the question in either of the general elections of the ensuing year to keep the funding in place.

If a simple renewal of an existing levy will not provide sufficient funding to

operate the district, the board may submit a renewal levy with an increase to the voters. It must first pass a resolution declaring the necessity of additional funding. The ballot question must state that the existing levy will be renewed and state the amount of the additional funding to be approved. This section of law also permits a park district to request a new levy or renewal and additional levy at any point during the term of the existing levy. The ballot language must state that the existing levy will be cancelled upon passage of the new levy.

The Park District of Ottawa County will expire on December 31, 2029 with the last year of collection in 2030. A renewal levy or a renewal and increase can first be submitted to the voters in November of 2029. The board is permitted to submit a new levy at any general election. As described above, it may also decide to renew and increase its levy at any point prior to 2029.

#### OTHER FUNDING

The board is authorized to accept donations in Section 1545.11 of the Ohio Revised Code. Donations of goods, services, or property may be accepted by the board. Any special terms of such donations must also be approved by the Probate Court.

The board may also seek to supplement tax funding through the use of public and private grants. The Park District of Ottawa County has been successful in obtaining grants for land acquisition and trail construction since the passage of the tax levy. Most grant programs require a local match, making local funding important. Since the passage of the tax levy in 2020, the park district has successfully raised \$2,020,273 in grant funding to supplement local funding. Without the local matching funds, these grants would not have been awarded. Park districts in Ohio are eligible for funding from the Local Government Fund. At this time, the park district does not receive funding from this source.

#### NON-PROFIT ORGANIZATION

The park district has the support of a 501 (c)3 non-profit organization, Friends of Ottawa County Parks. This group has the ability to raise funds to assist the park district with its mission. Work is currently underway to increase the presence of the organization in the community to provide a vehicle for private donations to assist the park district with its improvement of parks in Ottawa County.

#### FINANCIAL ANALYSIS


As a part of the strategic planning process, the fiscal health of the organization was reviewed. Actual expenditures from the start of collections of the existing park levy in 2021 and projected expenses through 2030 were collected and analyzed to demonstrate how the funding has been utilized. The results of this analysis are shown in the chart below.

The Ottawa County Auditor serves as the fiscal agent for the park district. Park staff process invoices for payment to submit to the county auditor for processing. Payroll processing is also handled by the county auditor's office.

In accordance with the laws of the State of Ohio, the park district is audited every two years for compliance with government accounting policies and procedures. Results of the audits are on file with both the state auditor's office and the park district. Audits have not revealed any issues with the operation of the park district and the management of its funds.

The park district received its first funds from the new levy in 2021. The park board began work toward finding and employing an Executive Director, paying for the election expenses from 2020 and working with consultants to create plans for the future operation of the district. Total expenditures in 2021 were 6.43 percent of revenues. (A detailed breakdown of revenue and expense is provided in Appendix E.)

In 2022, an Executive Director was employed. The first grants were awarded from the Parks and Trails Improvement Grant Program assisting local governments with park improvements. Planning for future projects continued during the year as consultants began work on park district improvement plans. Expenditures totaled 18.91 percent of revenues.

In 2023, additional part-time staff members were added. An administrative assistant and operations assistant were added to assist the director with the day-to-day operations. Work continued on planning for future improvements. Additional grants were awarded from the Parks and Trails Improvement Program. Total expenditures were 49.78 percent of revenues.

In 2024, the park district funded its first capital improvement project for improvements on the North Coast Inland Tail. Work on other projects including the Catawba Islander Trail Master Plan, the Marblehead Trail Feasibility Study, and land acquisition moved forward. The third round of grants to local political subdivisions were awarded. Total expenditures totaled 83.85 percent of revenues.

Revenue and expenditures through the end of the current levy and two years beyond have also been projected. These projections include changes in the operation of the park district that are contemplated in both the short-term and long-term goals found later in this report.

The 2025 budget for the park district includes a number of changes in expenses. In June 2025, the park district relocated to a new office location that will result in an increase in rent. Previously awarded grants from the Parks and Trails Improvement program will be spent. Further major work will be completed on the North Coast Inland Trail along with the anticipated construction of the first new park. Proposed staffing changes include a full-time operations manager to assist with capital projects, a seasonal maintenance worker to work on park care, and a seasonal naturalist to increase community engagement. Expenses in 2025 will exceed revenues by utilizing unexpended funds from previous years.



Projections for the next seven years include allowances for capital improvements, staff changes, a continuation of the Parks and Trails Improvement Grant Program. Through the last year of collection of the current levy, expenditures are kept within total receipts (including cash carryovers from previous years).

Minor additional staff changes are anticipated. In 2026 the seasonal naturalist position will increase from 600 hours to 1040 hours allowing additional programming. In 2027 the seasonal naturalist position is elevated to a fulltime position providing for year-round programming. A naturalist program is often referred to as the "face" of the park district by providing a way for the public to interface with the organization on a personal level. In 2027, an additional seasonal maintenance position is added to assist with care of additional park improvements. After 2027, no additional staff changes are projected in this plan. (However, changes in the operation and additional park improvements may necessitate additional staffing).



With the expiration of the current levy on December 31. 2029, the financial projections

anticipate the passage of a renewal and additional levy in November 2029 or in 2030. It is currently estimated that a renewal of the existing 0.6 mill levy with a small increase of 0.175 mill would generate additional funds for the operation of the district. Should a renewal and additional levy pass, annual revenue would increase from \$1.3 million to \$1.9 million. This increase would restore funding to the level originally approved in 2020 and fund additional capital improvements and increased operational costs. The park board could also opt to renew the existing levy without an increase which would provide the park district with funds to continue operations with \$1.3 million in annual revenue.

As noted above, the board could request a renewal and additional levy at any point during the term of the existing levy. (Ohio Revised Code 1451.21 (B)2) Any combination of mills is permitted with a renewal and additional levy.

The park board operates in a fiscally conservative manner. To that end, it strives to maintain a reserve balance that generates revenue for the operation of the district and to provide a cushion for a fiscal emergency in the future. The goal of the board is to have a cash balance of a least equal to the annual income of the levy that supports the district (as permitted by law).

#### Advance the Catawba Islander Trail and Greenway

 Continue development through Park District properties and trail easements with willing property owners.

- Advance connections to the Sandusky Bay Pathway.

#### Explore a Collaborative Park Development Project in Western Ottawa County

• Explore a partnership with Sandusky County Park District to create a new park (on land already publicly owned).

#### Enhance Portage River Water Trail

 Collaborate with partners to improve paddle craft launch areas and enhance overall water trail development.

#### Support County-wide Parks and Trails Grants

 Continue offering the Parks and Trails Improvement Grant for the benefit of the entire county.

#### Expand Educational and Recreational Programming

 Broaden outreach efforts and enhance programming across Ottawa County.

#### Enhance Operational Capacity

- Acquire essential equipment for Park District operations.
- Hire appropriate staff to meet operational needs.
- Develop and maintain a robust park district volunteer program while integrating support from Friends of Ottawa County Parks.
- Establish a central base of operations for staff and volunteers.
- Develop and implement operational and maintenance standards for park properties.

#### • Financial Balance

 Develop a comprehensive financial strategy for continuing operation of the park district including the allocation of funding for operations and capital improvements as well as recommendations for future funding initiatives.

#### **TEN-YEAR GOALS**

#### Extend the North Coast Inland Trail

 Complete the extension of the North Coast Inland Trail through Ottawa County, connecting to Wood County.

#### Integrate Eastern and Western Trail Networks

- Develop plans to connect trail networks in the County's eastern and western regions, including integration with the North Coast Inland Trail.
- Explore east to west trail routing through the Village of Oak Harbor.

#### Broaden Portage River Corridor Plans

- Expand access to the Portage River through:
  - » Preservation of natural resources.
  - » Improved connectivity for non-motorized on-land trails.
  - » Enhanced public access.

#### Promote Stewardship and Maintenance

 Develop and implement stewardship standards that will ensure proper care and maintenance of park lands and improvements owned by both the park district and partner agencies.

#### Collaborate on regionally significant projects

- Continue to develop Sandusky Bay Pathway plans and Ottawa County route options.
- Work with local communities, metropolitan planning organizations, and neighboring counties to explore the feasibility of developing a pedestrian corridor via the former Sandusky Bay Bridge and other trail connection opportunities.

#### Meeting Minutes Summary -PDOC Strategic Discussion

Presenter: Jannah Wilson - NCIT & PDOC Update

#### 1. NCIT Trail Updates

- o *Elmore to Genoa Section*: Martin-Williston on-road trail to be widened and repaved as a separate off-road path. Construction slated for 2025.
- o *Phase One Village of Genoa*: Extension of NCIT through Genoa to the abandoned rail line. PDOC received \$1.1M ODOT TAP grant for this expansion.
- o Former Rail Line: Acquisition process underway for future trail use.

#### **Discussion Highlights**

#### **Staffing & Operations**

- Jason Lewis inquired about PDOC staffing model.
  - Jannah Wilson: Current staffing is at capacity. Discussion underway with the park board about expanding staff. Priorities include hiring an Operations Manager (trail development, conservation, inspections) and a full-time Naturalist (programming, education, camps). Volunteer base is also being expanded.
- **Kim Kaufman** emphasized the need for broader staffing to support community programming and engagement. Offered **Black Swamp Bird Observatory** partnership opportunities in the interim.

#### **Vision & Planning**

- **Tom James**: Long-term planning includes Catawba Islander Trail Plan, Marblehead Peninsula Trail Feasibility Study, and expanding safe off-road biking routes. Emphasis on balancing project ambition with financial feasibility.
- **Quinton Babcock**: Called for clear priorities and financial planning to ensure sustainable infrastructure investment. Noted different visions and needs across communities.
- **Tom Bergman**: Stressed that PDOC levels the playing field in funding access between municipalities and villages. Expressed strong support for the grant program's impact.
- **Lisa Brohl**: Expressed excitement about levy support and matching grant opportunities. Highlighted public demand for shoreline access and continued grant programming.
- **Jasmine Cupp**: Asked about the *Active Transportation Plan* and its role in addressing lack of public transportation and access to public lands.
  - Jannah Wilson: The plan helps identify and address infrastructure gaps. Resulted in better local engagement, especially in places like Catawba, which is gradually shifting from resistance to support through outreach and greenspace preservation efforts.

#### **Community Engagement & Strategic Support**

- PDOC has supported several community park plans (Port Clinton, Oak Harbor, Elmore) and is exploring adding this as a formal part of its strategic planning process.
- Amanda Kovach: Emphasized quality in grant writing and project descriptions.
- **Dave Hower**: Expressed desire for park planning support due to inactivity in local park development.
- *Jannah Wilson*: Suggested PDOC could assist one community per year with a park plan as part of the strategic framework.

#### **Next Steps**

- PDOC to continue exploring staffing increases.
- Public meeting to be scheduled following this stakeholder session.
- Continued development and rollout of the grant program (Year 4 launching in October).
- Ongoing collaboration and partnerships encouraged to support programming and outreach.

- In 1992, Ottawa County Resident Mark Mulligan asked the County Commissioners to pass a resolution calling for the creation of a park district under Ohio Revised Code Chapter 1545.
- A resolution was passed by the County Commissioners and delivered to Probate Court on July 17, 1992.
- A hearing on the matter was scheduled for August 24 at 9 a.m. There was no opposition to the creation of the district.
- Probate Judge Zeitzheim ordered the creation of the district to include all of the territory of Ottawa County on September 1.

#### THE PURPOSES OF A PARK DISTRICT

#### Chapter 1545 of the Ohio Revised Code

Park districts have existed in Ohio since the early 1900's.

The board of park commissioners may:

- Acquire lands either within or without the park district for conversion into forest reserves and for the conservation of the natural resources of the state, including streams, lakes, submerged lands, and swamplands
- May create parks, parkways, forest reservations, and other reservations
- May afforest, develop, improve, protect, and promote the use of the same in such manner as the board deems conducive to the general welfare.



#### **AFTER 1992 CREATION**

- First work was focused on grants for work on the North Coast Inland Trail within Ottawa County
- · With no source of income, progress was difficult
- Sandusky County Park District purchased a portion of the trail corridor in 1999
- In the ensuing years, this portion of the trail was improved
- Sandusky County Park District transferred ownership of its portion of the trail to Ottawa County Commissioners in 2018

### 2018 A RENEWED INTEREST IN THE ROLE OF THE PARK DISTRICT IN THE COUNTY

- 1. Also in 2018, Ottawa County Commissioners formed a steering committee to create an Ottawa County Active Transportation Plan
- 2. The park district was active on the committee along with representatives from many Ottawa County organizations, subdivisions, and residents
- 3. Funded by the Ohio Department of Transportation
- 4. Residents and visitors supported the creation of safe bicycle facilities with the county
- 5. Strategy 1 of the Active Transportation Plan called for an active park district
- 6. Two additional board members were appointed in 2018 and the board set about reorganizing the park district and seeking funding for its operation

#### 2020 A PLAN TO ADVANCE THE PARK DISTRICT MOVES FORWARD

- 1. In May 2020, the park board enlisted the help of The Trust for Public Land (TPL) for guidance with a funding model for the park district
- 2. TPL researched funding methods for park districts and conducted a public opinion survey to gather opinions on the addition of a real estate tax to fund the park district
- 3. The proposed levy would be in the amount of .6 mill for a period of eight years.
- 4. The survey concluded there was strong support for a levy
- 5. The park board placed a ten-year levy on the November 2020 ballot, and it passed with just over sixty percent (60%) approval


