- 3. Minutes of Previous Meeting: Mike moved and Angela seconded to approve meeting minutes taken at 8/2/19, which were previously disseminated via email, and to waive a formal reading of such minutes.
- 4. Fiscal Report: No change since last report

- 6. Departmental Reports:
  - a. <u>Friends of The Ottawa Co. Park District (FoOCPD)</u>: Denny has sent letter for update to Rob Hayes, from LaFarge. Denny sent letter to Alexander Pike Project.
  - b. <u>Trail Project</u>: Gary and Denny went to Trustees meeting in Catawba. Gary introduced the OCPD. Linda suggested amending the Active Transportation Plan to incorporate Catawba. Per Linda, "We need to show site control." Site control will be an issue.
  - c. Magsig Farm: Review Gary's Email dated August 15, 2019
- 7. Unfinished Business:
- Mike brought up the trail at the mouth of the Portage River. The Commissioners will be looking into ownership and at the location of the trail.\*
- In order to receive OPRA funding we need to 1) be a member of OPRA and 2) submit a resolution. What needs to be in a resolution? Need to contact Gary or Woody.\* Angela will do so.
- 8. New Business:
- Genoa will not be looking further into continuing the trail at this time, per John Lewis, because of the costs and complication. Linda recommends the formation of a coalition between wood co, Ottawa co, ODot Jeff Shaner (who handles grants). Genoa, Milbury. According to John there may be a building located on or partially on the path. Per Linda "it is a perfect funding project." Per John, Thomas Bergman may be interested in helping. Will need site control. We could do a joint application by Feb 2020 with Wood Co. Angela will contact Wood Co Park District.\*
