- 3. Minutes of Previous Meeting: Minutes were read by Angela. Mike moved to approve minutes, Gary Seconded. Approval carried.

Departmental Reports: Friends have their next meeting on 3/22. Dennis reported that he received an email from Bob Hayes (Regional Environment & Land Services Manager | Aggregate Construction Materials | Great Lakes Region, Lafarge) which was forwarded to the Commissioners on 3/12. Response was that "no time table" was given to their logistics team to determine if the trial would ever be "economically feasible."

The Friends have been working on a website which is now published and they are able to receive donations via a Square reader and through PayPal.

6. Unfinished Business: Kim Morrison of PIB will be meeting with Gary on 3/29/19 at 8:00 am.

Next, the board discussed with Andy Brown a structure for donations and approvals of such by the Probate Judge. The Board decided that donations shall be treated as follows:

\$1.00-\$1,000 Receipt from the District

\$1,000-\$5,000 Probate Judge Approval and Judgement Entry

Additionally, the Judge may want reports (monthly, quarterly, etc). *Gary will be talking to the Probate Judge regarding donations and prepare Judgement Entry.

Regarding RC 5709.10 there is no taxation if used solely for community purpose. *See Montgomery co vs Kinney 61 Ohio St 2nd 88 (1980)*.

Additionally, Gary reached out to Priesman's Print and he will put together quotes on memorial envelopes.

7. New Business: Tom James of Environmental Design Group Consultants spoke about the company being a multidisciplinary design group/land planning firm that assists with bike trials. Their specialty is the environmental science needed for projects. They also do grant writing. In most cases they are paid separately from grants, or pro bono. If Tom James would be hired, he would work for the District Commissioners. There is no conflict with working with both Poggemeyer and EDG. The next step, in Tom's opinion, would be to arrange a private executive session with the land owners. Must be open meeting, then go into private executive session. 1. Meeting 2. Positive Intentions/addresses/names 3.

Letter of intent/memorandum of understanding from land owners 4. Binding contract. * Need to establish roles of Commissioners.
