4. Current Efforts:

a. Magsig Farm: next step to contact ODOT; Has LJ Overmeyer sent Mike the sketches/ideas of the barn, existing entrance, parking and new building ideas he indicated he had in his April 23 email?

Mike hasn't received any sketches from U.

b. Friends of The Ottawa Co. Park District (FoOCPD):

- i. We haven't heard from ODOT regarding our request to consider including a bike lane in the widening of Rt. 53 between Rt. 2 and Rt. 163. Denny will continue to try to discuss this with someone.

c. North Coast Scenic Inland Trail/Genoa/Millbury:

- i. Mayor Bergman communicated that the Genoa Council stated a willingness to provide funds for the appraisal portion of the purchase of the Norfolk and Southern property to facilitate the Genoa to Millbury trail if a suitable annexation agreement is put before them and approved. They are interested in annexing the property up to Fostoria Rd. with the Park District of Ottawa County still holding ownership.
 - 1. Next step to create a draft annexation agreement? Whose action?

We need confirmation from the Ottawa County Commissioners that Genoa can annex the property that the trail will be on. Gary will confirm.

Linda will call WE Realty and work with them to obtain a cost estimate for appraisal work.

2. Determined we need to create a PAC. Michael Bassett is willing to help with the creation. We need to identify a Treasurer.

Jack will work with Michael Bassett to form the PAC.

3. Awaiting update from Will Abberger from Trust for Public Lands. He was scheduled to meet with the Nature Conservancy/Doris Duke Foundation yesterday regarding a potential grant for polling. If we are interested in working with TPL, TPL needs a letter from OCPD requesting technical assistance from the Trust for Public Lands and The Nature Conservancy; example attached

- 4. Discussed the drafted letter to the Steering Committee at yesterday's Levy meeting. Gary will work with Linda to update the letter per the committee's discussion.
 - a. Intent is to provide an update
 - b. Acknowledge the help and support the Steering Committee has already provided
 - c. Provide a vision of the potential projects we could undertake
 - d. To bring to fruition we would need a levy
 - e. We will be communicating with them again soon
 - f. Beki H will create a Facebook page and Becky Q will take the lead in monitoring the page and developing responses, when appropriate. We will need help in making the Facebook page active and using it to spread our vision, the positive impact we can have, the benefit to individual residents, the county and its tourism attraction
- iv. We will quickly be creating a Fact Sheet describing our accomplishments to date and our next steps
 - 1. We will need to speak a common message to:
 - a. Communicate our vision
 - b. Generate enthusiasm
 - c. Respond to negative input
- Unfinished Business:
 - a. Have learned that our website cannot be hosted on the Ottawa County servers. In discussions with Doug Rogers, we will need to purchase a host site via a third party such as NameCheap or GoDaddy. Cost estimate is typically ~\$30 per year. NameCheap currently is offering a special price of \$22/yr. The county will add a link on the left side menu of the Ottawa County website, named "Park District" when we are ready to "go live" with the website
 - i. Judy is working with Doug Rogers to create and develop a website; will need to ensure consistency with our Facebook page
 - ii. Do we need to pass a resolution changing our meeting notification protocol when the website is up and running?

Board agreed Judy should work with Doug Rogers to develop a website for the OCPD.

Currently our bylaws require us to post meeting notices at the Courthouse, at our Office and in the Beacon. If we want to change this, we will need to formally change our bylaws.
