BE IT FURTHER RESOLVED, that Jack Madison, Park Commissioner, will continue to act as liaison for the Catawba Island Township Advisory Committee by attending meetings of the Committee and reporting back to the Park District Commissioners of any actions and concerns from the Advisory Committee, it being understood that Mr. Madison will consult with the Park District and other persons (as approved by the Park District of Ottawa County) as deemed beneficial to the group and the proposed bicycle/pedestrian path in Catawba Island Township, and

3E IT FURTHER RESOLVED, that the Executive Director-Secretary will retain all public records and reports related to the Catawba Islander Trail project, and

BE IT FURTHER RESOLVED, The Executive Director-Secretary will take part in communications with land owners in conjunction with Board of Park Commissioners and the Advisory Committee, and

BE IT FURTHER RESOLVED, that it is found and determined that all formal actions of this Board concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Board, and that all deliberations of this Board, and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
