3. Fiscal Report – Meeting Minutes for August 2, 2022 – Jannah Wilson reported that the fiscal report for August 2, 2022 was included in the Board Packet which she emailed to the board members. Jannah also reported that the \$2000 donation for the Bike Safety Day was deposited in the Park District's Ottawa County account. Donations will now be reported in a revenue report. - 4. Public Comment Meeting Minutes August 2, 2022 No discussion.
- Executive Director's Report(s) Meeting Minutes for Auguat 2, 2022
 - Jannah Wilson provided the board with draft maintenance agreements for the North Coast Inland
 Trail. The board discussed developing new maintenance agreements with Genoa and Millbury for
 the Genoa to Millbury extension, first, (prior to trail construction) before modifying maintenance
 agreements in place for the Martin Williston Rd to Elmore portion of the trail. Jannah Wilson will
 communicate board questions related to the maintenance agreements to County Administrator
 Rhonda Slaughterbeck.
 - Jannah Wilson provided information related to Shores and Islands grant opportunities including the upcoming Destination Development grant. The board will discuss in more detail at the next public meeting on August 16th.
 - Jannah Wilson provided the donation policy draft. She will make modifications to it to include reference to the Park District of Ottawa County bylaws and original donations judgement entry. She will also fix typos. A final version will be ready for approval with a resolution at the next board meeting on August 16th.
 - Jannah Wilson mentioned the 18-month strategic plan outline that was attached to the board packet. She included a one-page document which includes a summary of each goal and action item for reference purposes.
 - Jannah Wilson mentioned Bike Safety Day will be conducted at Hopfinger Zimmerman Memorial Park on August 3rd. 20 students are registered. Gary Kohli mentioned he plans to attend.
