- Executive Director's Report(s) Meeting Minutes for September 6, 2022 4.
 - 1. Jannah Wilson reviewed an opportunity presented to her by Jason Lewis of the Ottawa National Wildlife Refuge for the Park District of Ottawa County to partner with the U.S. Fish and Wildlife Service to develop and utilize the Marinewood Unit on State Route 163, West Harbor Road. The site is located on the Portage River approximately halfway between Port Clinton and Oak Harbor. The site could be strategic to creating an Arts and Adventure Corridor between Port Clinton and Oak Harbor, building on the arts theme and incorporating outdoor active opportunities, with a kayak launch for the Portage River Water Trail and a future multi-use trail along State Route 163 connecting the Port Clinton Arts Garage and the Oak Harbor Riverfront area. The site includes a barn which could be used for storage. A visitor center could be constructed to provide meeting space, trailhead restrooms, and could be used to house and display indigenous artifacts collected from the local area and now held elsewhere. While not ready to prioritize this opportunity, the board agreed that Jannah should continue to explore the opportunity with Jason Lewis.
 - 2. Jannah has been invited and plans to attend a Lake Erie Coastal Trail meeting. The board agreed.
 - 3. Ottawa County Engineer Ron Lajti would like us to send a letter of support and be part of applying for a Safe Streets and Roads for All grant. The board agreed and Jannah will send a letter of support.

 - 5. Jannah Wilson reported that the Oak Harbor Apple Festival is October 8 and 9, 2022 and she is working on volunteers to support the Park District at the festival.

Meeting Minutes for September 6, 2022 – It was agreed that Jannah Wilson and Gary Kohli would meet with Andy Brown, Sandusky County Park District Executive Director and anyone else Andy would like to include, to discuss the future of Magsig Farm.

ACTION: *Jannah Wilson to work with Andy Brown of Sandusky County Park District to execute the 15 year lease of Magsig Farm by the Park District of Ottawa County from the Sandusky County Park District.* ACTION: *PDG, Tim Bock, to inform the Park District when they could begin accessway to the Magsig Farm and what their construction schedule would be, noting that a group of Boy Scouts would like access so they can begin making improvements to the area in an attempt to achieve their Eagle Scout badge. The Boy Scouts would like to complete their work by June 2022*

e. Catawba Islander Trail and Greenway Meeting Minutes for September 6, 2022 – Lauren Falcone, Poggemeyer Design Group, reported that they continue work on the Catawba Islander Trail and Greenway Master Plan. Harper is working on maps delineating the various trail options. Lauren reported that she contacted Larry

Fletcher from Shores and Islands Ohio regarding tourism data for Catawba and they do not track data in that manner. Lauren will work with Ottawa County and the Miller Fairy to determine if they collect data that will be helpful. She would like to include testimonials in the material she is developing. Possible sources for testimonials were identified as Linda Amos, Elmore Village Council, Jason Lewis who lives in Elmore. Lauren confirmed, the Ottawa County Auditor does not have a "second home" category in their database and suggested we ask the Ottawa County Auditor if she can tell us what percent of property tax bills are sent out of the county. Lauren indicated she will send a final draft of the public survey to Jannah Wilson and the board members for review. She noted that before the survey can be sent out, we need to set the Public Meeting date. It was agreed to set the date of the Public Meeting by Friday September 9, 2022. Lauren plans to use Survey Monkey for the survey and the link to the survey will be made available on various social media platforms. We will also ask the Beacon to send out a Press Release regarding the survey and the link will be included. A discussion was held regarding whether we could send a postcard to the Catawba Island Twp. property owners, particularly the full time residents, with the link included on the postcard, inviting them to participate in the survey. It was agreed that we should determine if we can obtain the list of Catawba Island voters from the Ottawa County Board of Elections. It was also suggested that a question should be added to the survey asking the participant if they see a benefit to the community with the various new park/preserve areas, e.g. the Nehls Memorial Nature Preserve, Cedar Meadow Preserve, the new kayak launch on State Route 53, etc. Jannah indicated that she plans to ask the Friends to support the development of renderings illustrating various options for trail boundary development, e.g. a special type of tree, a privacy fence, natural overgrowth, etc. It was suggested to include a rendering of the golf cart prevention barriers to be included in the trail. It was agreed that it is important for the Park District to know how we will manage or help mange the security on the trail and be able to describe this clearly before the public meeting.
