Jannah also reported that the Ottawa County Engineer's team plans to work on the Martin Williston Rd. county improvements in January. Road improvements will be led by the county funded through a grant Clay Twp. has received. Bike trail work will be funded by the Park District.

Jannah Wilson noted she and Jack Madison had a good meeting with the Ottawa County Engineer to discuss the Catawba Islander Trail and Greenway. He provided suggestions for the project.
