3. Fiscal Report - Meeting Minutes for January 17, 2023 - No discussion; Fiscal Report given at first meeting of the month.

ACTION: Jannah Wilson to determine who other public entities use as a financial advisor.

- 4. Public Comment Meeting Minutes for January 17, 2023 Tracy Colston reviewed Port Clinton's ideas for the city beach and lighthouse area.
- 5. Executive Director's Report Meeting Minutes for January 17, 2023
  - a. Jannah Wilson reviewed a table of the board's 2023 meetings and locations along with topics and priorities for that meeting. Jannah noted that she will maintain the Park Board's meeting schedule in Google Calendar which is accessible on the Park District's website. She requested board members reference this calendar for the most up to date schedule and meeting location. She noted she has a few more meeting locations to schedule.
  - b. Jannah Wilson reported that she received a question from the Put-in-Bay Park District regarding a significant land purchase they would like to make and their need for funds for the cost share needed to apply for a grant for the purchase. She noted that our Grant Program framework indicates that an entity must own or have a long term lease on property they plan to improve and are applying for a grant for. She also noted that the framework does not exclude land acquisition from receiving a grant. Jannah has asked the Ottawa County Prosecutor if we are able to provide funds for other government entities to purchase property and is awaiting a response. Jannah noted that the project Put-in-Bay Park District is working on has three phases and she reviewed the three phases. It was noted that the Put-in-Bay Park District did not pass their levy during the Fall 2022 election. It was also noted they have been quite successful in obtaining donations. The board will await the Prosecuting Attorney's response.

- c. Jannah Wilson reviewed at a high level the Park District of Ottawa County Priority Score Sheet she included in the board packet. She explained that the scoresheet includes our projects as well as administrative priorities. She noted that while we have approved our Employee Manual and Volunteer Policy, there are still a number of additional policies we need, e.g. Purchasing and Contract Policy, Rules and Regulations. Jannah noted she will send the priority scoresheet in Excel to all of the board members and requested that the board members review the scoresheet and return their scores to Jannah for aggregation.
- d. Jannah Wilson reported that the Solid Waste District grant deadline is the end of January with a second application round due at the end of June. Mike Shadoan noted that a project to install signs for the Boy Scout Kayak launch could be a viable recipient.
- e. Jannah Wilson reported that she has received 2 applications for the Part-time Administrative Assistant role. She noted that one of the applicants asked about medical benefits. Medical benefits for part-time workers was discussed. It was suggested that workers who work 30 hours per week may be eligible for medical benefits. Jannah will ask Michelle Ish, Ottawa County HR, what the policy is.

ACTION: \*Jannah Wilson to ask Jason Lewis ONWR Manager, if they have an intern who may be able to work with the ONWR and the Park District to identify funding sources for jointly developing Marinewood.\*

## 6. Old Business

a. North Coast Inland Trail/Genoa/Elmore - Meeting Minutes for January 17, 2023 - Mike Shadoan noted that Bellevue has extended the NCIT through their downtown by increasing the width of their sidewalks to 10 ft. He asked Tracy Colston if this might be possible in Port Clinton. Mike also noted that some municipalities have required new developments to include bike friendly sidewalks in their developments. The board and Tracy discussed possibilities for integrating trails in Port Clinton with the goal to connect Port Clinton to Catawba and Marblehead. It was noted that updating the Active Transportation Plan would provide an opportunity to brainstorm these ideas. Mike Shadoan asked if Jannah had contacted Mike Netz regarding the NCIT. Jannah noted that she was waiting until it was decided who would be responsible for managing the NCIT. Jannah also reported that the Prosecuting Attorney confirmed that the Park District cannot fund anything, including volunteer tshirts, for the Friends.
