North Coast Inland Trail/Genoa/Millbury Meeting Minutes for February 21, 2023 Jannah Wilson reviewed a proposed Memorandum of Understanding between the Park District of Ottawa County and the Genoa Banking Company, memorializing the intent of each to work together to develop a trail route on property owned by the Genoa Banking Company within the Village of Genoa. The trail is intended to provide a linkage on the Genoa Banking Company property in the Village of Genoa, between the current terminus of the North Coast Inland Trail and the future trail route to Millbury. Jannah requested the board approve Resolution 2023-03 Park District of Ottawa County and Genoa Banking Company, North Coast Inland Trail Genoa to Millbury which approves her, as the Executive Director-Secretary, to sign the MOU.
